NOTICE REGARDING THE ESTABLISHMENT OF A SPECIAL INVESTIGATIONS COMMITTEE

Nippon Telegraph and Telephone Corporation ("NTT" or "the Company") hereby announces that, in response to a report related to the NTT Group published in the March 4, 2021 edition of the "Shukan Bunshun" (the "Incident"), NTT has decided to establish a special investigations committee consisting of an Independent Outside Member of the Board of the Company, an Independent Outside Audit & Supervisory Board Member of the Company and external legal experts for the purpose of clarifying the facts and investigating the cause of the Incident, as further described below.

The Company will fully cooperate with the investigation of the special investigations committee.

The Company sincerely apologizes for any inconvenience and concern this may cause to all related parties.

- 1. Purpose of Establishing the Special Investigations Committee
 - (1) Investigation as to the existence of any cases related to the Incident between officials of the Ministry of Internal Affairs and Communications (which is the regulatory body responsible for licensing and making important policy decisions for the NTT Group) and NTT Group's management team
 - (2) Clarification of the facts related to the cases identified in (1) above
 - (3) Recommendations for countermeasures and other related matters
