In connection with the matters previously announced on May 9, 2022 in the press release entitled "Notice Regarding Realignment to Strengthen the Global Business of NTT Group (Change in Lower-tier Subsidiaries)," Nippon Telegraph and Telephone Corporation (the "**Company**") hereby announces that the board of directors of NTT DATA Corporation, a consolidated subsidiary of the Company, has resolved that it will change the trade name of the split preparation company (the "**Domestic Business Split Preparation Company**") that it had established on November 1, 2022 as a wholly owned subsidiary, to "NTT DATA JAPAN CORPORATION" on July 1, 2023, as further described below together with additional details regarding the Domestic Business Split Preparation Company that had previously not been determined.
